

This document (together with the documents referred to on it) tells you the terms of use which apply when making use of our website www.sensorydimensions.com ("our site"), whether as a guest or a registered user. If you do not agree to these terms of use, please refrain from using our site.

1. Information about us

2. Accessing our site

11. Prohibited uses
